- Iowa Auto Recyclers will ask that language be added to Iowa law that will require a buyer at a salvage pool to use a government issued identification document to be assigned a unique identifier and that licensed recycler use their NMVTIS number. The measure will maintain integrity in the market and assist DOT in tracking and enforcing the number of salvage vehicles acquired by one entity so as not to exceed the annual six-vehicle threshold.
- 2) Iowa Auto Recyclers will ask that language be added to Iowa law that will allow licensed auto recyclers in the state to report salvage vehicles as "CRUSHED" in the NMVTIS system in lieu of securing a junking certificate. Recyclers will retain the title in lieu of the junk certificate.
- 3) Iowa Auto Recyclers will ask that language be added to Iowa law that implements a state NMVTIS reporting consolidated system that will allow licensed recyclers to report to and query NMVTIS as part of the biennial licensing fee. The consolidated system will be integrated with Iowa DOT records.

- A) House Study Bill 56: An act relating to the discharge of motor vehicle security interest. When a security interest is discharged, the holder shall note a cancellation of the security interest on the face of the certificate of title over the holder's signature and may note the cancellation of the security interest on a separate, notarized release form or letter. The holder shall deliver the certificate of title and the form or letter, if applicable, to the county treasurer where the title was issued.
- B) Senate File 81: An act relating to unfair or deceptive motor vehicle repair practices. 3. An insurer that issues or delivers a policy of motor vehicle liability insurance in this state that provides coverage for the repair of property damage to an insured motor vehicle shall do all of the following: a. Authorize repairs to be made to the insured motor vehicle using genuine crash parts sufficient to maintain the manufacturer's warranty for fit, finish, structural integrity, corrosion resistance, dent resistance, and crash performance. b. Shall not require repairs to be made to the insured motor vehicle using aftermarket crash parts. (Considering change from MONITORING to OPPOSED)
