Legislative Initiative

The Board was presented with an overview of a bill draft that would ask to implement an Iowa NMVTIS system and establish the requirement for using an NMVTIS number (or other identification) for the purpose of acquiring salvage in Iowa. An Iowa NMVTIS system would allow free unlimited reporting and look up to all licensed recyclers.

Vendor Presentation

Dan Miller, Legend Smelting & Recycling, made a presentation on evaluation of catalytic converters. Dan presented the material from the summer outing with the powerpoint that had technical difficulties in June. The catalytic converter market has had some nefarious activity and Dan assisted the Board in determining professional evaluation processes and payment expectations. The Board of Director Members also donated catalytic converter to the Iowa Auto Reccyelrs to kick off the upcoming fundraiser event. The donations amounted to \$420 paid to IAR. The association is running a series of fundraisers as a means to continue to fund the scholarship program and to keep from raising dues while the industry struggles with the metal market meltdown.

Sanborn Auto, Inc. Sanborn, IA passed in December 2015 that required the automakers to provide recall data to auto recyclers so that unsafe parts can be kept from the marketplace.

There is more work to be done with the acquisition and utilization of parts data. The recall data also needs to be provided to auto recyclers in batch form so that the inventory management system can integrate the data at point-of-sale.

Swift travelled to Washington D.C. repeatedly last spring to educate the stakeholders group in the processes of auto parts dismantling. The OEM's assertion that all consumers had access to recall information at www.SaferCar.gov fell far short of understanding that recalls were issued daily and checking the VIN of a vehicle upon acquisition was not meeting the needs of either the auto recycler or the consumer. Multiple recalls on single VINs is not uncommon and there must be a solution to having real time access to the information.



That solution is batch data processing so that information can be flagged at point-of-sale through the inventory management systems.

The understanding of this "customer first" philosophy is also what lead ARA to ask for ALL VIN data to be released for auto recyclers usage. Access to all parts data will enhance the customers access to economical used parts options. The data is already available in other countries as well as other industries in North America.

While OEMs tout their environmental commitment by building nesting boxes for ducks from recycled battery boxes or using recycled blue jeans to make carpet they fail to see the bigger picture in closed loop recycling. The ORIGINAL RECYCLER *reuse first* model is still far superior to any other end-of-pipe repurposing program.

But other issues drive the initiative forwards as well. Consumer preference to make environmentally friendly choices must include used auto parts. It make sense on a global scale for local consumers to be able to replace a worn or broken auto part with perfect VIN match used auto parts. It is good for the local economy, good for the environment and

Iowa Business Tax Incentives Verify You are Getting Credits

The state of Iowa offers a number of programs providing tax credits or other incentives which can reduce taxable obligations and help increase your company's bottom line. Business Property Tax Credit: What is the Business Property Tax Credit? The Business Property Tax Credit is part of the overall 2013 property tax reform bill that was enacted by the Iowa Legislature and signed by Governor Branstad.

What Property is Eligible for the Credit? This credit is available for certain commercial, industrial and railroad properties. The credit is applicable to individual parcels as well as "property units." One credit is available for each qualified parcel or property unit. What is a Property Unit? A property unit is a new concept specific to the credit. The law defines a property unit as contiguous parcels of the same classification that are owned by the same person, located in the same county, and operated by that person for a common use and purpose.

How can I Obtain a Credit for my Property? You must apply for the credit by completing an application form. You should contact your county or city assessor for instructions on how to obtain and complete an application form as each assessor may be handling the application process differently. You can find information on how to contact your assessor at the follow-

Pollution Control or Recycling Property Tax Exemption: Businesses making improvements to properties primarily used to control air or water pollution, or used primarily for recycling, may qualify for a property tax exemption. Iowa DOT Debuts Online License Renewal Online Payment Option through ARTS System

Beginning immediately, dealers and recyclers of all types are now able to renew their licenses quickly, easily, and immediately online. The new service allows licensees to order new dealer plates and print the license credential that is required to be displayed at your place of business. Your license renewal application form will indicate whether your license may be renewed online. If you are eligible, the form will provide a personal identification number you will use in conjunction with your license number — to log in at the website.

Previously, the Iowa DOT asked that each licensed recycler provide an email to DOT including their NMVTIS number in an email to DOT to help prepare for this online renewal option. Iowa Auto Recyclers provided the list to DOT so that many of our members will have online renewal as an option.



The Iowa DOT clarified that the increase in bond for Used Car Dealers to \$75,000 for this renewal period DOES NOT mean that a Recycler now needs a bond too. Several callers to Iowa DOT have misunderstood the DOT information that was sent to all Used Car Dealers and Recyclers in the same letter to mean Recyclers now need a bond. THAT IS NOT TRUE. If you are a Recycler **only** and not a Used Car Dealer then the bond information does not apply.



Is Cheap Insurance the Least Expensive? Insurance professionals Offer Advice to Recyclers

lowa Auto Recyclers asked our professional insurance members to answer some questions on getting the right policy in place.

Bill Velin (Assured Partners)

The old adage "the cheapest insurance isn't always the least expensive" has never been more true. The ultracompetitive nature of the insurance marketplace has led to insurance companies offering coverages not offered in the past, as well as adding exclusions and limitations that take out coverages that you thought you had. The smart insurance buyer knows how to read his policy and where to look to find the coverages he or she needs to protect his business.

The policies written for today's automotive recycling industry are particularly tricky to construct and read due to the many different and diverse exposures found in the typical recycling operation. These exposures can range from dismantling and recycling cars and trucks to the sale of new and used parts to the sale of used cars or trucks, plus U-Pull-Your-Own yards and the recycling scrap metal. These coverages all have idiosyncrasies that, if not covered properly, could mean the difference between a claim being paid or denied outright. In addition, each of these exposures have different coverages including but not limited to Property, General Liability and auto that all may contain exclusions or limitations that render your perceived coverage very restrictive or make it very broad, depending on the carrier and the policy forms.

For example, a simple property policy for a typical recycler can be a trap where you think you are covered well because most property policies are written with a coinsurance clause. If the property policy, for example, was issued with a 90% coinsurance clause, that means that the value you have your building insured for has to be at least 90% of what it would cost to REPLACE after a loss. For instance, you have your building insured for \$900,000 at 90% coinsurance. A fire damages one portion of the building and the estimate to repair it is \$300,000. AFTER the loss, the insurance company will come in and do a replacement cost calculation using a normally accepted replacement cost analysis. Let's say, for the sake of argument, that they come up with a replacement cost of \$1,200,000. The coinsurance clause will be enforced in this case, since you were required to have the building insured for a minimum of \$1,080,000 (90% of \$1,200,000). However, you only have the building insured for \$900,000, which is 83% of what you were required to have it insured for per the



coinsurance clause (\$900,000 /\$1,080,000 = 83%). Therefore, you will receive only 83% of the \$300,000 fire loss or \$250,000 minus your deductible. You are not going to be happily insured in this case, which is a perfect example of a situation where the cheapest insurance is not always the least expensive.

Another prime example is in the garage liability section of the policy. Many recyclers perform mechanical repairs on customer vehicles. That means they could have several customer's vehicles on their premises sometimes overnight. This creates a "bailees exposure" for customers vehicles in your care, custody or control. If damage occurs to a customer's vehicle, you want to be able to assure your customer that you have coverage for the damage to his vehicle. However, even though you have a garage-keepers liability policy, you do not necessarily have coverage for your customer's *vehicle.* That is because garage-keepers liability can be written in a number of different ways – from "legal liability" which covers damage to your customers' vehicles that you be LEGALLY OBLIGATED to pay (i.e. damage caused only by your negligence) to "direct primary coverage", which covers just about anything that happens to a customer's vehicle. Quite obviously, Legal Liability is much cheaper than Direct Primary. However, it may cost you much more in lost customers than you saved in premium for going with the cheaper option – especially if you are not aware of what you are buying. Again here, the cheapest option will probably turn out to be more expensive in the long run.

It is more important than ever to find an insurance agent that is willing to spend time teaching you to become a better and smarter buyer. Once you learn to be a smarter buyer, you will not only save money in the long run, but you will sleep better knowing your business is covered properly.

Is Cheap Insurance the Least Expensive? Insurance professionals Offer Advice to Recyclers

Q: Does my certification safety program help me save money on my insurance?

Mark DuBay (Professional Solutions Insurance Services): The Absolutely! Having a documented safety program that is also implemented by your business is a critical element of your entire insurance program. When your insurance renews or when we request updated quotes on your premium, it helps to show that you are doing the right things to make safety a priority. For example, if you hold a safety meeting and have employees sign in when they attend, this document can be provided to the insurance company underwriters. It's just one way to demonstrate that a safety program is in place.

And, when the right documentation carrier to not cancel coverage if is provided for your safety program, it often results in more credits that reduce your insurance premium.

Amee (LSB Financial): Yes. Underwriting a new account for placement with the carriers who have the best rates and coverage definitely includes examining safety protocol and practice. It is an integral part of the process. An operation's safety program is also considered when looking for rate deviation or the addition of a dividend program. A good safety program can also help tell a carrier how you plan to eliminate or mitigate future loss which can help convince a

there has been loss in a policy period. A well-written and followed safety program tells your agent and the carrier that you take your trade seriously and understand the impact loss can have on a company and its assets.

Cody (Bank Iowa): The safety program can help keep your premiums down by decreasing the chances of workplace accidents. Frequency of workers compensation claims can have a great impact on the Experience Modification Factor, which is used to calculate the premium for Workers Compensation.

Q: What impact does the recent flooding have on my policy or costs?

Mark DuBay (Professional Solutions Insurance Services): The If you have a flood insurance policy with the federal government (often required if you're in a flood zone), your rates will not be affected the same as if you have a policy through a standard insurance carrier. In some cases, a flood is considered "an act of god" and your business may not be affected in terms of premium increase. Keep in mind that policies cover different things so your standard insurance would include your business vehicles and there's a flood, your coverage could be affected at renewal. There's not one set answer when it comes to flooding but I'll be happy to talk with you about available coverage options and solutions.

Amee (LSB Financial): As with any business a company will spread expenses across the board to minimize the impact to one region. With any natural disaster those cost in one way or another get spread to all of us at some point. The impact on individual rating is of course largely about location and your placement in a flood zone. Growing up in a river town I personally understand the impact flooding has on a community. I have witnessed firsthand how each flood changes the river and how the water is displaced differently each time it floods. Homes and areas that have never had water before are impacted, while areas who traditionally were underwater are minimally impacted. Every person

should visit the idea of Flood coverage with their agent. Depending on your location and history, coverage can sometimes be added at minimal cost.

Cody (Bank lowa): Flooding doesn't have an impact on your business policy. Flood insurance is a separate insurance policy. Flood insurance is an optional coverage. If you have a loan on the property, most lenders do require the flood coverage. Without flood insurance, the cost of repairs are completely at the owner's expense.

Q. What one thing do you advise clients to do to save money or get better coverage with their insurance policy?

Mark DuBay (Professional Solutions Insurance Services): The best starting point is a structured safety program (see the first question). ency is key in developing a healthy relationship with your agent to make sure you are covered for all aspects of possible risk . Each carrier packages coverages a little differently and may include coverages you would never need. A thorough policy review should be annually be your agent, and together every three years. Q: What is one thing you advise your clients to do to save money or get better coverage with a policy?

Cody (Bank lowa): I advise my clients to re-evaluate their equipment every couple of years. Make sure they complete their audits every year. Make sure they keep detailed records, and the audit process will be smoother. It is also important to have each employee in the correct class code. For each employee, have records of regular pay, overtime pay, and third party sick pay. Hold safety meetings to help keep workplace accidents down, helping your mod factor on the workers compensation. I also go over self-insuring which means going over what the cost would be with higher deductibles. Sometimes the risk of taking

on more self-insurance is worth the lower premium.

OSHA's role is to ensure these conditions for America's working men and women by setting and enforcing standards, and providing training, education and assistance. For more information, visit <u>www.osha.gov</u>.

Under federal law, employers must provide a workplace free of known health and safety hazards. Additionally, OSHA has enacted an ANTIRETALIATION RULE that bans retaliation in the workplace for employees that report incidents of injury and illness that took place at work.

One of the goals of this recordkeeping rule is to improve the completeness and accuracy of injury and illness data collected by employers and reported to OSHA. When workers are discouraged from reporting occupational injuries and illnesses, the information gathered and reported is incomplete and inaccurate.

Employees are required to make employee aware of the new rule with the notification of the new rule due by November 10, 2016. On the next page is a poster that can be the used to convey the information. Post it in an employee accessible area such as the breakroom.

Section 11(c) of the OSH Act prohibits employers from discriminating against their employees for exercising their rights under the OSH Act. These rights include filing an OSHA complaint, participating in an inspection or talking to an inspector, seeking access to employer exposure and injury records, reporting an injury, and raising a safety or health complaint with the employer. If workers have been retaliated or discriminated against for exercising their rights, they must file a complaint with OSHA within 30 days of the alleged adverse action.

Right to Report a Work Related Injury Employee Safety is a Team Effort

Under federal law, you are entitled to a safe workplace. Employers must provide a workplace free of known health and safety hazards. If you have concerns or injuries, you have the right to speak up **without fear of retaliation**. You have the right to report a work-related injury.

Key Points: • Promptly report all injuries, "near misses" and hazards. • You will not be "blamed" for reporting an injury or a job hazard. • Keep a constant lookout for potential hazards. • Take responsibility for your own safety.

Why report injuries? If you or a co-worker are injured at work, it's important to report it to a supervisor as soon as possible – even if the injury is minor. Sometimes, incidents occur which almost lead to injuries but don't, these are called "near misses." It's important that you report these, too.

Here are some reasons why you should promptly report all injuries and near misses: – so you can get first aid or medical attention to prevent a minor injury from becoming infected or otherwise getting worse – so your co-workers don't get hurt as well – so we can take preventive action, such as putting a safety guard on a sharp blade or posting a "warning" sign, in order to avoid serious injuries in the future.

We care about your safety, and the safety of all of our employees. That's why it's important that we know about any unsafe conditions.

Workplace Safety is a Team Effort!

DO'S AND DON'TS of INJURY AND HAZARD REPORTING

DO:


Ask for help if you get hurt – even if the injury is minor.

Join in Co-Sponsoring Legislation to Enhance Consumer Safety and Choice by Providing Access to OEM Part Numbers throughout the Automotive Supply Chain

- In November 2015, Congress passed the FAST Act that includes a provision that requires automotive manufacturers to provide OEM parts data for recalled components. It was signed into law on December 4, 2015.
- Congress must now work further with the family-owned small businesses that make up the automotive recycling industry to require automakers to remove barriers so that **all** parts data is available. This legislation will keep service and repair parts affordable and safe for consumers.
- The Automotive Recyclers Association (ARA) is dedicated to the efficient removal and re-utilization of genuine original equipment manufacturer (OEM) automotive parts, and the proper recycling of inoperable motor vehicles. <u>ARA believes it is critical to establish national policy that promotes effective competition in</u> <u>the market for replacement parts.</u>
- Each day over 4,500 automotive recyclers sell more than 500,000 recycled OEM parts as an affordable repair option for consumers. These are the very same parts designed by automakers to meet fit, finish and durability standards that continue to operate as they were originally intended in terms of form, function, and safety performance.
- The complexity of today's automobiles and the motor vehicle recall epidemic underscore the importance of access to VINspecific OEM parts identification information. Access to OEM part numbers and identifying parts information is critical to supply chain management that best serves the consumer.
- Different types of vehicles need different types of replacement parts, even parts within the same make, model, and year may differ. For instance, 2014 F-150 trucks were manufactured with at least 15 different side mirror options. Specific



OEM parts data by VIN would easily make an exact match for a *reasonably priced replacement part* from the massive inventory of used auto parts available.

Our global partners agree. The European Union regulations require vehicle manufacturers to ensure independent repairers have easy, restriction-free, and standardized access to vehicle repair and maintenance information.


