The session is currently in overtime with not end in sight. Our Lobbyist, Jim Obradavich, reports to the Board of Directors weekly with progress on bills of interest.

Most recently Jim reported on "the stalemate between the House and Senate and Governor continued for a third week at the Statehouse. Both chambers did "gavel-in and gavel-out" on Monday and Thursday of this week but did not conduct any business. Some behind the scenes budget conversations are taking place between members of the Senate and House, but no formal talks have been reported."



Iowa Automotive Recyclers Legislative Wrap Up

CAT CONVERTER THEFT BILL ON WAY TO THE GOVERNOR

The IAR-backed bill to make catalytic converter theft more difficult is now on its way to the desk of Governor Reynolds. Senate File 2287 establishes new rules for the sale of used catalytic converters for transactions between businesses as well as transactions between an individual and a scrap metal dealer. For a business transaction the seller must provide the purchaser with a copy of their valid sales tax permit.

For a transaction between an individual and a scrap metal dealer the seller must present the original receipt or invoice for the replacement converter purchased not more than 30 prior to the transaction. The individual shall receive payment using a traceable payment method including but not limited to payment made by check, voucher, issuance of a prepaid bank, credit, or debit card."

COSMETIC DAMAGE EXEMPTION

SF 2139 (formerly SSB 3001) - Cosmetic Damage (M) - This bill authorizes an owner of a wrecked or salvage vehicle to apply for and be issued a regular certificate of title without repairing cosmetic damage. The bill exempts a motor vehicle that is considered wrecked or salvage solely due to cosmetic damage from the salvage theft examination otherwise required, and the owner of such vehicle is not required to submit a salvage theft examination certificate when applying for a regular certificate of title. The bill defines "cosmetic damage" as "dents, paint chips or scratches, hail or wind damage, or other minor damage that does not alter the mechanical operation of the motor vehicle." Cosmetic damage does not include any damage caused in a vehicle crash or collision, or a broken or missing window, headlamp, tail lamp, directional signal device, electronic sensor, or other component part necessary for the safe operation of the vehicle. 



The changes re-formatted Material Safety Data Sheet (MSDS) to Safety Data Sheets (SDS) in a standardized 16 Section format so that employees can more easily access information on chemicals in the workplace. By now employees should have been trained on the newest format.

One of the less known requirements of the update is that **container labels must also be in SDS format.** Tank labels will need to contain six elements; 1) Product Identifier (Name of the Chemical); 2) Signal words (Danger or Warning or None); 3) Pictograms; 4) Hazard Statements; 5) Precautionary Statements; 6) Company Information. Employers are required to train Employees on these new elements and the new GHS pictograms.

The OSHA requirements DO NOT include the NFPA (National Fire Protection Association) diamond system of hazard identification because the OSHA update aligned with the United Nations global initiative and the NFPA is a national system used in the U.S. Use of the fire diamond is still a requirement by the local fire departments.

Ideally the tank labels used at an automotive salvage facility will meet all of the standards required such the OSHA SDS secondary label format, waste identification for EPA and state Department of Natural Resource requirements as well as the NFPA waring. Plus the labels should be durable such as chemical resistant and weatherproof if tanks are located outdoors.

Finally, vessels of all sizes must be labeled. That mean tanks and totes obviously, but it also means transfer buckets, jerry cans, telescoping drain tray containers and elevated fuel tanks too.
